Note: IF CANDIDATES ARE NOT AVAILABLE IN A PARTICULAR SPECIALITY, THEN CANDIDATE WITHOUT PG QUALIFICATION BUT HAVING AT LEAST THREE YEARS EXPERIENCE AFTER MBBS OUT OF WHICH ONE YEAR JUNIOR RESIDENCY IN GOVERNMENT HOSPITAL OR MCI RECOGNISED PRIVATE HOSPITAL IN THE SPECIALITY CONCERNED WILL BE CONSIDERED FOR A PERIOD OF ONE YEAR ONLY SUBJECT TO THE CONDITION THAT FRESH SELECTION PROCESS HAS TO BE DONE BY END OF ONE YEAR. EXTENSION FOR ANOTHER YEAR SHALL BE ALLOWED TO THESE MBBS DOCTORS WITH THREE YEARS EXPERIENCE IF AGAIN NO CANDIDATE WITH DIPLOMA/PG/DNB/DM APPLIES. THE TOTAL PERIOD OF SUCH EXTENSION WILL BE LIMITED TO THREE YEARS OF TOTAL SENIOR RESIDENCY AS IN SENIOR RESIDENCY SCHEME.

# TERMS AND CONDITIONS FOR SERNOR RESIDENTS WORKING IN RAILWAY HOSPITALS

## **Minimum Educational Qualification:**

- Post Graduate Degree /DM/DNB or Diploma in the specialty concerned from university recognized by State /Central Government.
- If such candidates are not available in particular speciality, then candidates without PG qualification but having at least three years experience after MBBS out of which one year junior residency in Government Hospital or MCI recognized private hospitals in the specialty concern can be considered for a period of one year only subject to the condition that fresh selection process has to be done by end of one year. Extension for another year will be allowed to these MBBS doctors with three years experience if again no candidate with diploma/PG/DNB/DM applies. The total period of such extension will be limited to three years of total senior residency as in senior residency scheme.

## Age Limit for appointment as Senior Residents:

- 33 years for those having Post Graduate qualification
- 35 years for Post-Doctoral Degree holders.
- Relaxation of age limit from 33 to 40 years will be considered only if there is no candidate or applicant who satisfy the laid down age limit of 33/35 years (PG/DM)
- Relaxation of 5 years for SC/ST candidates
- Relaxation of 3 years for OBC candidates

## **Selection Process:**

Selection will be through interview.

#### **Tenure of Senior Residency:**

The contract of appointment of Senior Residence will be one year but the total period Senior Residency cannot exceed the maximum period of three years, subject to renewal / extension every year.

• The termination of contract can be done on one month notice or pay from either side.

#### **Emoluments:**

## For Senior Residents having post graduate degree

Basic Pay + NPA

Rs.67700 + 20% NPA in the first year

Rs.69700 + 20% NPA in the second year

Rs.71800 + 20% NPA in the third year

#### For Senior Residents with only PG Diploma

the above amount shall be reduced by Rs.325/- per month and the same will be reduced by Rs.650/- per month if without Diploma / PG Degree.

<u>For Senior Residents who are pursuing DNB training also,</u> the emoluments will be fixed by National Board of Examination or as above which ever is higher.

#### **Allowances:**

## 1. NPA(Non Practicing Allowance)

The element of such allowance has been included in the monthly emolument indicated above.

#### 2. PG allowance

For PG degree holder - Rs.200/- per month.

For PG Diploma holder – Rs100/- per month.

This allowance is also already included in the total emoluments mentioned above. Hence, in case the Senior Resident is having only PG Diploma, a sum of Rs.100/- and in case he/she neither has PG Degree nor Diploma, a sum of Rs.200/- per month will be deducted from his/her emoluments.

## 3. Dearness Allowance, (HRA & Transport Allowance)

Entitlement to these allowances is as per Central Government rules on the basis of their monthly emoluments.

#### 4. Book Allowance

Book Allowance to be granted to the Senior Residents at the rate of Rs.1500/-per annum in two installments of six months each. The books/journals purchased shall be embossed at three places by an officer appointed by the head of institution for this purpose.

## **Accommodation:**

Free residential unfurnished accommodation would be provided to Senior Residents subject to availability.

#### Leave entitlement:

- One day weekly off by rotation.
- Entitled to total 20 days leave in one contract year which can be availed as not more than 10 in six months period.
- Not entitled to any vacation or any other type of leave.

# **Medical treatment Facility:**

- Free OPD treatment Medical facility as available in Railway Hospital will be provided to the Senior Residents for self, spouse & children.
- Free indoor Medical treatment as available in Railway Hospital will be extended to self only in emergency and acute illness situation
- There shall not be any provision for referral to other Private Medical Centres for treatment.

# **Duties and Responsibilities:**

- Duties and responsibilities of the Senior Residents will be as fixed by the Railway administration from time to time.
- They will be required to perform any work as may be needed in the legitimate interest of Railway administration including National Programmes or during Railway accidents, in addition to their speciality work.
- The Senior Resident Doctors will be required to be on call duty not exceeding 12 hours / day.
- No private practice shall be permitted.
